Financial Assistance for Performance Sport Trainee Judges Policy

Rationale

For Performance Sports to continue to develop and exist it important for HDTC to promote and encourage Club members to pursue Judging accreditation in the Performance Sports discipline of their choice.

In acknowledgment of the time and cost a Trainee Judge incurs in pursuing their accreditation the Club will upon the Trainee Judge meeting the below criteria reimburse upon the provision of receipts of costs incurred, an amount up to and not exceeding \$500.00.

Method of Payment

Upon the fulfilment of the criteria the financial assistance will be made in two (2) equal instalments of two hundred and fifty dollars (\$250.00). The first upon the Trainee Judge successfully passing the Theory Exam and the second instalment upon the Trainee Judge becoming accredited.

It is expected that a Trainee Judge will becoming accredited within a 2-3 year period from commencing their accreditation.

Criteria

1. Financial Club Member for a minimum period of 2 years prior to application.
2. Active Club member that has or had competed in the discipline and or volunteers their time to educate Club Members in the discipline or a discipline at the Club.
3. Written application for financial assistance to the Club, detailing the Performance Sport the applicant is seeking Judging accreditation in.
4. Written confirmation of acceptance into the Trainee Judges Program, provided by the governing body.
5. Substantiation of expenses amounting to \$250.00.
6. Written confirmation of attaining a pass in the Theory Exam.
7. Written confirmation of attaining a pass in the Practical Exam, Accreditation and the substantiation of expenses amounting to \$250.00.
